

Let's go change the world.


### WHO IS NATIVITY PREPARATORY ACADEMY?

Our students come from a variety of diverse backgrounds, with more than 20 nationalities and multiple faith traditions including Catholicism, Islam, Buddhism, Baptist, and other Christian denominations.

But they all have several things in common: They have not been well served by the schools they attended and are several years behind grade level when they first arrive at Nativity; and they come from families that, while economically disadvantaged, truly care about education.

During their time at Nativity Prep, our students take part in a college-preparatory academic experience, as well as personal and spiritual enrichment that will last a lifetime.

### **VOLUNTEERS: THE HEART OF NATIVITY**

Martin Luther King, Jr. said, "Life's most persistent and urgent question is, 'What are you doing for others?'" For an evergrowing group of dedicated people in the Rochester community, the answer to that question is, "I volunteer at Nativity Prep!"

The model for Nativity Preparatory Academy is based on the idea that it truly does take a village to raise a child. Each day, the faculty, staff, and administration at the school welcome dozens of volunteers to partner with them in educating, encouraging, supporting, and inspiring our students.

One of the many unique elements of Nativity Prep is the Extended Day schedule, which includes one hour each day for both homework and enrichment activities. During homework time, students have access to their teachers along with a large group of volunteers who work one-on-one with those who need a little extra help. Nativity's Enrichment Program is facilitated by a flurry of volunteers who coach sports, encourage the artistic talents of our students, expand on their academic experiences, and show them new ways to have fun in their free time. Nativity Prep is a tuition-free school, and therefore is dependent on the generosity of our community to generate funds

for operating expenses. Community volunteers help Nativity's fundraising efforts through events, consulting services, and outreach to prospective donors.

These are a just few ways that members of the Rochester community support Nativity Prep through the donation of their time and talents. Nativity could not offer this unique educational experience without the volunteers who take time out of their days to help the school live its mission, and for that, the Nativity family is eternally grateful.

### NEW POSITION IN SUPPORT OF OUR STUDENTS

Beginning with the 2018-2019 school year, Nativity added a Director of Student Support Services and Programs position. This role encompasses social emotional learning and counseling, high school placement and graduate support, enrichment programming, and community service. Adding this position allows Nativity to more fully and holistically care for the unique gifts and needs of students as they grow to practice and perform the five Nativity virtues.

Meredith Smith serves as the Director of Student Support Services, and comes to Nativity Rochester after a two-year teaching fellowship at Nativity Boston. While in Boston, Meredith completed her masters degree in Applied Developmental and Educational Psychology at Boston College's Lynch School of



Education, and taught 4th-7th grade Social Studies and Writing and coordinated the college volunteer and community service programming at Nativity. Meredith is originally from the Minneapolis area of Minnesota, and attended Boston College for undergrad as well. She is thrilled to be continuing to work for the Nativity mission, and is looking forward to getting to know the Nativity family in Rochester.

### **SUMMER PROGRAM**

Nativity Prep's *Summer Gear-Up Academic and Leadership Program* serves to supplement and reinforce what is learned throughout the academic year, and also gives our students a safe, productive environment to spend their summer days.

The program includes:

- A 1-week academic remediation program for any student who did not achieve grade level performance in a core subject
- A 2-week academic and enrichment day camp for all new and returning students that focuses on core academic needs in the morning followed by enrichment sessions for "experiential learning" in the afternoon
- A 1-week overnight camp experience at Camp Asbury on Silver Lake, complete with academics, team-building activities, opportunities to enhance leadership skills, and overall summer fun.

Throughout Nativity's *Summer Gear-Up Academic* and *Leadership Program*, our students stay engaged academically, socially, and spiritually, and are better prepared to begin the school year ready to forge ahead on their journey to both academic and personal success.




